On November 27th, the ku klux klan was stopped from marching in Washington D.C. by the Black community, especially its youth. This was a major victory for the Black community and for all anti-racist and progressive people in this country. But the klan's planned march in D.C. was only one part of its strategy to legitimize its white supremacist movement nationally and locally and be able to recruit masses of white people into its ranks. With a particular emphasis on organizing a "Youth Corps" and on recruiting women, the kkk is concentrating on its military strategy to defend white supremacy and build fascism. Most of its major leaders work under the direct leadership of the U.S. government. For example, Bill Wilkenson, head of the Invisible Empire has admitted to being a paid FBI informant and David Duke, head of the NAAWP ("National Association for the Advancement of White People") is a known CIA agent. Many klan members serve in the police, the military, or work as prison guards. This helps to point to the klan as a primary tool of the U.S. government in waging terror and counterinsurgency against Black people and the revolutionary forces that lead their liberation struggle. The New Afrikan Independence Movement, because it fights for land and independence for the Black Nation, is a key target of the U.S. government and the kkk. We contribute to the defeat of the klan by building strong support for the Freedom Fighters like the Black Liberation Army who have emerged from Black people's 400 year struggle in this country for human rights. These Freedom Fighters are waging an offensive struggle to liberate the New Afrikan (Black) nation and to defeat U.S. imperialism.

The open klan organizing in the suburbs of Maryland and Virginia with crossburnings, racist propaganda, rallies and public statements must alert every progressive person - anyone who is concerned with stopping the rise of organized white supremacy. The klan is organizing to defend the system, U.S. imperialism, which is responsible for the economic crisis and increasing racism and brutality in our society. To stop the oppression of black people, the exploitation of women and all working people what we need to do is fight against the system. In order to stop the klan and nazi organizing, we need to take public stands against the klan; expose their organizing at our jobs, on our campuses, in our children's schools and in our communities. To oppose racist terror we must give unconditional support to the right of Black people to self-defense by any means necessary. By taking public stands against the klan and building opposition to their organizing we contribute to Black people's struggle for human rights and to the defeat of the klan.
