

- 7:00 am Leave PRCC
- 11:00 am Arrive at McDs after driving about 215 miles, 25 miles past Terre Haute
- 11:45 am Leave McDs
- 12:00 noon Arrive at Wabash prison
- 1:00 pm Leave Wabash prison
- 1:45 pm Arrive at Terre Haute FCI after driving 34 miles
- 2:45 pm Depart Terre Haute FCI and drive 4 miles
- 3:00 pm Arrive at Terre Haute Courthouse; eat and clean up
- 4:00 pm Demonstrate at courthouse, by monument directly facing Route 41
- 5:00 pm March across the street and through Indiana State University
- 6:00 pm Leave Terre Haute
- 10:00 pm arrive PRCC

Caravan Travel Details for May 4

1. Take I 94 East to Rte 41 South, which is the second exit (Exit 2A) in Indiana, 28 miles from the Loop.
2. Continue on Rte 41 for 89 more miles after getting on Rte 41 and take Rte 63 as it forks away from Rte 41. This happens near the town of Attica, Indiana.
(You have now gone a total of about 117 miles from the Loop.)
3. Continue on Rte 63 towards Terre Haute until you come to Terre Haute, which is 70 more miles. Then, get back onto Rte 41 which again rejoins Rte 63 and continue going south on this dual route. (see Map #1)
(You have now gone a total of about 187 miles from the Loop.)
4. Go for about another 26 miles on Rte 41 to an intersection which is at Rte 154. Rte 154 is very small but at this intersection there is a McDonalds at one corner, a Burger King at another, and a Hardy's and Days Inn at another. Pull into the McDonalds. (see Map #2)
(You have now gone a total of about 213 miles from the Loop.)
5. Continue on Rte 41 for 8 more miles south. You are now at Wabash "Correctional" Institution (see Map #3). The prison is on your left as you drive south. Just after you pass the prison, you will come to a place in the road where you can turn around. Take that turn around, and immediately get out of your vehicle on the shoulder of the road. This is where we will demonstrate. Vehicles will return to McDonalds but now park in Burger King lot or Hardy's lot for exactly 40 minutes. Then vehicles will return and pick up demonstrators.
6. Leave Wabash prison. Drive north on Rte 41 for 32 miles. At the intersection with a Chevy/GM dealership on your right, make a left onto Springhill Road. (see Map #1)
7. Go 1.5 miles and once again you will come to Rte 63. Continue past that and go .5 miles more. You are now at Terre Haute FCI. Park your vehicles and get out and demonstrate.
(See Map #1)
8. Return .5 miles to Rte 63 and take it north for 4 miles. We are heading for the Terre Haute courthouse which is the biggest building in town and can be seen from everywhere. Take Rte 63 until it turns into Holman Street. Make a right onto Holman Street. Then go 3 more streets and make a left onto Rte 41. You will then pass the courthouse. Make a left on Cherry Street, after the courthouse, and park in the lot. Demonstrate at the courthouse. (See Map #1)
