After three trials and one dismissal, the government via the puppet State of New Jersey, is still trying to flog and legally lynch an uppity field nigger, Assata Shakur s/n Joanne Chesimard. The u.s. government has further made it possible to commit atrocious acts upon this Black woman in the name of THE PEOPLE. We know the truth. THE PEOPLE are not against Assata, and have demonstrated this fact with the verdicts they returned:

Trial #1

Charged and accused of bank robbery by the F.B.I through their very own paid off, habitual liar Avon White, coerced into informing and making deals to save his own skin. VERDICT: NOT GUILTY.

Trial #2

Dismissed

Trial #3

Accused of robbery and kidnapping for ransom a known dope pusher of deathly drugs to the Black people in our communities. Once again a castrated negro male who fabricated testimony after being instructed and coerced into doing so by New York authorities from the F.B.I down to the Brooklyn ,N.Y D.A's office. VERDICT: NOT GUILTY.

Trial #4

Accused and charged with a bank robbery in Brooklyn. Again Assata protested her innocence, willingly stood up for a line-up and was not picked out as the robber of the bank by u.s. government's so called eye witness. VERDICT: NOT GUILTY.

And now for the New Jersey Turnpike....a fourth trial, where the states attorney will try to make the victim look

like the criminal and the criminals look like the victim. To this fourth accusation Assata has again proclaimed her innocence. To the state of New Jersey and to the ears of the world Assata has resounded her will to be free! She has maintained her innocence for 2 1/2 years and it has been the people's verdict that has confirmed her truth. Those of us who know the tactics and attitudes of State Troopers towards motorists can certainly reconcile ourselves to Assata's assertion of being NOT GUILTY.

We urge you the people not to believe what you read in the newspapers. They have been wrong too many times before. They just want to sell their papers. Make your own investigation by coming to court and giving your support. The trial will begin the first or second week of March in New Brunswick, New Jersey ; Judge Applebee presiding. We urge you the people not to participate in this vile depravation being carried out in your name and your honor. Assata needs financial as well as spiritual support.

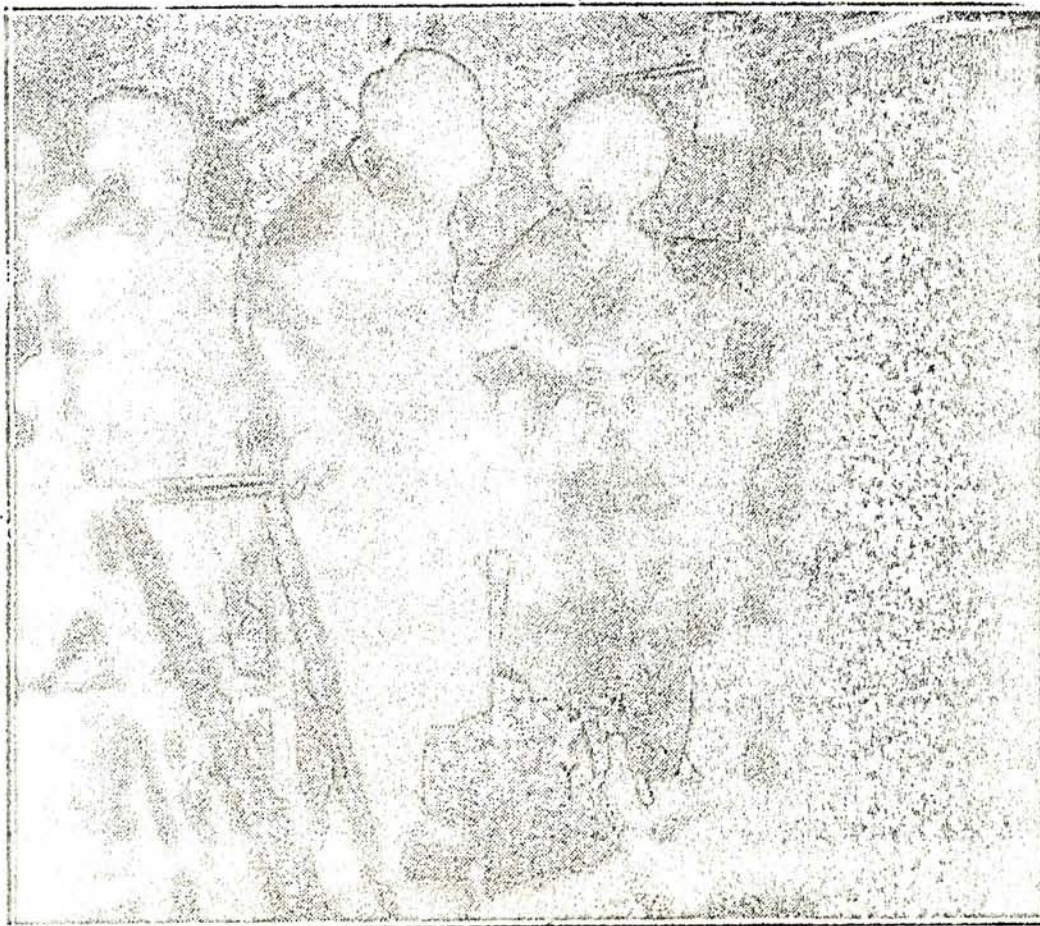
