

## STOP THE BOMBS FROM CONCORD TO EL SALVADOR

DEAR BROTHERS AND SISTERS ON BEHALF OF THE SALVADOREAN COMMUNITY IN THE U.S. WE WANT TO CONVEY OUR GREETINGS AND OUR HOPES FOR PEACE ,FREEDOM AND JUSTICE.

WE ARE DEEPLY TOUCHED BY PEOPLE LIKE BRIAN WHO HAVE MADE OUR SUFFERING THEIRS AND WHO WITH GREAT COURAGE AND SACRIFICE WORK FOR AN END TO THE SUFFERING AND DEATH IN OUR HOMETLAND. TODAY WE STAND WITH YOU ,BRIAN, AND WITH YOUR FAMILY AND FRIENDS JUST AS YOU HAVE CONTINUE TO STAND BY US.

WE ARE OUTREGED THAT THE IMMORAL U.S. POLICY OF WAR IN CENTRAL AMERICA HAS REACH THE EXTREME OF GENERATING VICTIMS IN ITS OWN TERRITORY. IT IS INCONCEIVABLE THAT THE TAXES OF THE NORTH AMERICAN PEOPLE ARE BEING USED NOT ONLY TO CREATE SUFFERING AND DEATH IN EL SALVADOR AND NICARAGUA, BUT ALSO TO BRUTALLY STOP LEGITIMATE AND PEACEFUL PROTEST OF U.S. CITIZEN TO THEIR GOVERNMENT'S POLICY.

WE HAVE RETURNED ONE MORE TIME TO CNWS TO PROTEST THE EXPORT OF DEATH TO EL SALVADOR AND NICARAGUA, WE FEEL THAT THE U.S. GOVERNMENT IS DETERMINED TO INCREASE THE SUFERING OF OUR PEOPLE.

IN RECENT WEEKS THE GOVERNMENT OF EL SALVADOR HAS BEGUN A BRUTAL WAVE OF ATTACKS , KIPNAPPINGS AND ASSASSINATIONS AGAINST THE POPULAR MOVEMENT ALONG WITH THIS .DEATH SQUADS HAVE BECOME ACTIVE ONCE AGAIN, THREATENING AND HARRASSING OPPOSITION LEADERS WITH TERRORIST TACTICS.

MOST RECETLY, ONE OF THE LEADERS OF THE MOTHERS OF THE DISAPPEARED WAS CAPTURED AS SHE LEFT A PEACEFUL GATHERING AT THE HALL OF JUSTICE IN SAN SALVADOR, THE LEADER OF THE UNIVERSITY EMPLOYEE'S UNION (PART OF THE U.N.T.S.) HAS BEEN KIDNAPPED AND HIS WHEREABOUTS ARE UNKNOWN .ALL THIS HAS HAPPENED IN THE LAST WEEK, SINCE THE BRUTAL ATTACK INSIDE MARIONA PRISON BY PLAIN CLOTHE SECURITY FORCES, THESE FORCES OPEN FIRE AND THREW A GRENADE AT POLITICAL PRISONERS WHILE THEY WERE SLEEPING ONE OF THE PRISONERS VLADIMIR CENTENO WAS CRITICALLY INJURED , HIS BODY IS FULL OF SHRAPNEL , THE LEFT SIDE OF HIS FACE IS PARALIZE AND HE IS IN GREAT PAIN. THIS IS HOW THE GOVERNMENT OF EL SALVADOR RESPONDS TO THE CRIES FOR PEACE , JUSTICE. AND FREEDON BY MILLONS OF SALVADOREANS.

EL SALVADOR IS LIVING THE WORST POLITICAL , ECONOMIC, SOCIAL CRISIS OF OUR HISTORY , THE GOVERNMENT HAS SHOWN A LACK OF CAPACITY TO RESOLVE THE BASIC DEMANDS OF THE MAJORITY OF SALVADOREANS, IT HAS ONLY INCREASED THE PAIN AND SUFFERING OF ALL OF US.

THE PEOPLE OF EL SALVADOR ARE CONFIDENT THAT BY WORKING TOGETHER WE CAN BRING AN END TO THE MASSACRES , THE PERSECUTION , THE DISAPPEARANCES , AND THE VIOLATION OF HUMAN RIGTHS IN OUR COUNTRY, WITH THIS IN MIND THOUSAND OF SALVADOREANS REFUGEES FORM MESA GRANDE CAMP, HONDURAS ARE PLANING TO RETURN IN OCTOBER TO REPOPULATE THE TOWNS FROM WHICH THEY WERE DISPLACED , THOUSANDS OF WORKERS WILL MARCH IN SAN SALVADOR SEPT. 15 TO DEMAND THE

CONTINUATION OF DIALOGUE BETWEEN THE FMLN-FDR, AND FOR PEACE AND JUSTICE IN OUR COUNTRY. THEY CHOOSE TO MARCH KNOWING THAT MARCHING AND WORKING FOR CHANGE MEANS RISKING THEIR LIVES, BUT THEY ARE DETERMINED TO DIE STRUGGLING FOR JUSTICE RATHER THAN TO DIE OF HUNGER AND MISERY.

PRESIDENT DUARTE HAS REFUSED TO CONTINUING THE DIALOGUE WITH THE FMLN/FDR HE HAS VIOLATED THE AGREEMENTS OF LA PALMA AND AYAGUALO NOW HE HAS BEGUN TO VIOLATE THE PEACE AGREEMENTS OF GUATEMALA BY INCREASING REPRESSION AND CONTINUE TO VIOLATE THE HUMAN RIGHTS, THE GOVERNMENT OF EL SALVADOR AND THE MILITARY HIGH COMMAND DON'T HAVE THE WILLINGNESS OF FINDING OR WORKING FOR PEACE IN OUR COUNTRY OR IN THE REGION, IN CONTRAST THE FMLN-FDR, HAS MADE REPEATED CALLS TO RESUME TALKS WITH THE GOVERNMENT, AND THE HIGH COMMAND, AS PART OF THEIR COMMITMENT TO A PEACEFUL SOLUTION TO THE CONFLICT THEY ARE PLANNING TO MEET WITH PRESIDENT OF COSTA RICA OSCAR ARIAS TUESDAY SEPT 8 IN COSTA RICA, THE DELEGATION OF THE FMLN/FDR WILL INCLUDE JOAQUIN VILLALOBOS, DR. GUILLERMO UNGO, RUBEN ZAMORA, SALVADOR ZAMAYOA.

THE REAGAN ADMINISTRATION IS ALSO COMMITED TO CONTINUE ITS SUPPORT FOR THE DUARTE GOVERNMENT, AND IF THEY FIND IT NECESSARY, THEY WILL INVATED EL SALVADOR IN ORDER TO REVERSE THE EFFORTS OF THE SALVADOREAN PEOPLE FOR FREEDOM AND JUSTICE THE REAGAN ADMINISTRATION IS ALREADY SPENDING 1.5 MILLONS DOLLARS A DAY, 750 MILLONS IN 1987. THIS MILITARY AID FOR DEATH AND DESTRUCTION HAS RESULTED IN 500,000 CITIZENS DEPOPULATED FROM THEIR HOMES, AND 1 MILLON FORCE INTO EXILE AROUND THE WORLD THIS IS A HOLOCOST.

WE MUST STOP THE AID TO EL SALVADOR AND THE AID TO THE CONTRAS WE MUST CONTINUE TO DO WHATEVER IS NECESSARY TO STOP THE SUFFERING OF OUR PEOPLE, AND ASSIST THEM IN THEIR STRUGGLE FOR JUSTICE AND FREEDOM.

WE SHALL STOP THE BOMBS FROM CONCORD TO EL SALVADOR THE WISH OF BRIAN WILLSON AND THE DREAMS OF THE SALVADOREAN PEOPLE OUR DREAM FOR PEACE AND JUSTICE WILL COME TRUE ONLY IF WE CONTINUE WITH STRONG AND CONSISTENT ACTIONS TO PROTEST THE HUMAN RIGHTS VIOLATIONS AND STOP THE U.S. INTERVENTION IN EL SALVADOR AND CENTRAL AMERICA.
